Pihl, Charles R. age 72, of Wayzata, died peacefully April 5th with his family at his side. Preceded in death by parents, Carl R. and Alva Pihl; sisters, Helen Brack and Fern Halverson. He was an aircraft pilot, world traveler and collector of automobiles and western and wildlife art. There was nothing he enjoyed more than spending time with his family and
