Edward "Eddie" Charles Reimer age\_76\_of Gaylord died April 1st, 2021 in his home in Gaylord. He was born on July 30, 1944 in Gaylord, MN, where he spent his entire life. He was the son of Everil "Evy" Reimer and Florine (Walter) Reimer.
