Mathieu, Felicity Abby Jane (Lissy) Age 27 of Hartland, Minnesota tragically died Wednesday, February 1, 2012. Felicity (Lissy) was born October 13, 1984 in Mitchell, SD. With her family, she moved to Akita, Japan at age 5, attended Kawazoe Elementary School from Kindergarten through 4th grade and became fluent in Japanese. Felicity graduated from Prior Lake - Savage High School (MN) and went on to graduate from Normandale Community College. Following several years serving as a special education paraprofessional educator, she pursued a baccalaureate degree from Walden University and would have graduated this spring with specializations in non-profit management and women's studies.
